- I understand there are to be no mobile food trucks in Village limits during the Clearwater Rodeo.
- I understand the permit I receive with this application is nontransferable and agree that the permit will be used by no one other than to whom it was issued.
- I understand if I am found to be in violation of the terms of this application or any portion of Clearwater Ordinance 2022-12, I will be fined a sum of not less than \$250 nor more than \$500 for each day of the violation.
